### 4. FIRST AID MEASURES

#### Description of necessary measures

**Inhalation:** On inhalation of concentrated spray mist: fresh air; if adverse health effects persist seek medical advice.  
**Skin contact:** First aid measures not required. Cosmetic product and therefore not necessary.
